

## WEBSITE COOKIE POLICY

As **E.C.S. ELEKTRİK ENJEKSİYON VE KABLO SİSTEMLERİ SAN. TİC. A.Ş.** (Hereinafter "**Company**"), we would like to state that we show the maximum sensitivity for the personal data of our website visitors to be processed in accordance with the Law on the Protection of Personal Data no 6698 and the relevant other legislation ("**KVK Legislation**") and we use cookies through our website.

The purpose of this Cookie Policy is to inform you about the types and purposes of use of cookies, obtained by the visit of the <https://www.ecselektrik.com> website, which is operated by us ("**Site**"), by the site users/members/visitors ("**Data Owner**").

### What is a Cookie?

Cookies are small text files stored on your computer or mobile device ("device") when you visit a website, enabling the detection of the device in question, mostly consisting of letters or numbers.

### What is Your Personal Data Processed Through Cookies?

By means of cookies, your habits of use and visit on the site, your session information, past transactions and navigation information are processed.

As the company, we process your personal data consisting of cookies that we collect through log files, empty gif files and/or third party resources in accordance with KVK Legislation, provided that it is limited to the following purposes:

- Your information of navigation on the Site are processed in order to provide a better service to our site visitors and shared with third parties being limited to this purpose and stored safely.
- Your past transactions are stored in order to create a summary about your preferences.
- Considering your marketing permission, your information of navigation on the Site and/or your use history on the site may be monitored, for the purpose of making promotions special for you, presenting promotions and marketing offers, improving the content of the Site according to you and/or determining your preferences.
- Functional and analytical cookies are used for the purpose of analyzing how the Site is used and for improving your experience of using the Site.

The company may match the information collected by different methods as online and off-line or information collected from you on the Site at different times and it may use this information together with the information obtained from other sources such as third parties.

### Which Type of Cookies Are Used?

In our site, both first party cookies (placed by the site you visit) and third party cookies (placed by servers other than the site you visit) are used. Below you can find different types of cookies that we use in our site:

- **Mandatory (Fundamental) Cookies:** These are the cookies, the use of which is mandatory, in order to ensure that the site properly operates and you can make use of its features and the services offered. For example, authentication cookies, which step in when you log on to our site, ensure that your active session continues when you switch from one page to another on our site. Disabling these cookies may cause services and features to become unusable.
- **Persistent Cookies:** These are the cookies used to increase the functionality of the site, offer a faster and better service to our visitors and remain valid until they are deleted by you through browsers or

until their expiration date. Such cookies are used to remember the preferences you made and personalize your use of the website. This usage includes cookies saving your password and ensuring your website session remain continuously open, thus releasing you from the trouble of entering password more than once at your each visit as well as the cookies remembering and recognizing you at your next visits on the website.

- **Session Cookies:** These are the temporary cookies used during your visit on the site and deleted after the browser is closed. Such cookies do not contain personal data and help reducing the need for transferring the personal data on internet. You can delete these cookies or prevent their usage; but disabling these cookies may cause the performance of the Site to decrease and your user experience to be restricted.
  
- **Google Analytics:**
  - **Function:** Monitoring / Analysis
  - **Purpose of Use:** Measuring and analyzing visitor movements coming to the site from different angles, in order to increase performance and user experience.
  - **Working method:** It provides collective, anonymous data about the screens on which you navigate within the <https://ecselektrik.com> site and about what you do.
  - **Cookie Type:** Third Party, Permanent and Session Cookies

### How can you control the use of cookies?

The use of cookies is not mandatory for being able to use our site; you have the opportunity to change the settings of your browser and personalize your preferences about cookies.

If you set your browser in such a way to block all cookies, you can continue to use our site but you may not be able to access all functions of the Site or may have restricted access; the quality of your user experience may decrease.

### What Are Your Rights as the Data Owner?

We would like to state that you have the following rights in accordance with Article 11 of KVKK:

- learning whether your personal data has been processed,
- if processed, requesting information about this,
- Learning the purpose of processing and whether it is used in accordance with the purpose,
- Knowing the third parties in country or abroad, to whom your personal data is transmitted,
- In the event that the personal data has been processed incompletely or incorrectly; requesting it to be corrected and requesting that the transaction made within this scope is notified to third parties to whom the personal data has been transmitted,
- In the event that the reasons requiring processing disappear although it has been processed in accordance with KVVK and other relevant law; requesting the personal data to be deleted or destroyed as well as requesting the transaction made within this scope to be notified to third parties to whom the personal data has been transmitted,
- Objecting to the occurrence of a consequence against the person himself by analyzing the processed data exclusively by means of automated systems,
- In case of suffering a damage due to the processing of the personal data in violation of the law, requesting the damage to be indemnified.

You can submit your requests with respect to your rights in question, preferably by filling out all the information specified in the [Respective Person Application Form](#) included in our website,

- Through the notary public or registered letter with return receipt in written, in order to ensure that your identity is detected and no information is given to wrong persons,
- By sending an e-mail to the address [kvkk@ecselektrik.com](mailto:kvkk@ecselektrik.com), using the secure electronic signature, mobile signature or (if any) the e-mail address previously notified to our Company and registered in our systems

or through other methods to be determined by the Board in the future.
